Local Government Act 1972 – Section 214 & Schedule 26 Cemeteries and Crematoria Local Authorities' Cemeteries Order 1977

The Parish Council of Great Shelford, being the Burial Authority for the Parish of Great Shelford for the purposes and having the function given to it by, the provisions of the above mentioned Act and Order, at its meeting of 15th August 2018 fixed and settled the following fees in connection with burials in Great Shelford Cemetery.

The person to be interred or in respect of whom the right is granted must be before his/her death, a past or present inhabitant or parishioner of the Parish of Great Shelford or in the case of a still-born child, where one of the parents is, or at the time of interment was, such an inhabitant or parishioner.

Part 1 INTERMENT

For any interment. £225.00

The fee indicated above does not include the digging of the grave. If the grave being provided is of double depth it will be assumed that application has been made for the exclusive right referred to in part 2 (i) below and a deed of grant will be issued.

Part 2 EXCLUSIVE RIGHT OF BURIAL

Part 3 MONUMENTS, GRAVESTONES, TABLETS & MONUMENTAL INSCRIPTIONS

For the right to erect or place on a grave in respect of which the exclusive right of burial has been granted:-

(i)	A headstone not exceeding 1.35 metres in height.	£225.00
(ii)	A vase or tablet not exceeding 750mm in height.	£225.00
(iii)	A cross of hardwood not exceeding 600mm in height and 610mm in width.	£225.00
(iv)	A flat kerb not exceeding 7 inches x 3 inches.	£245.00
(v)	A flat tablet not exceeding 300mm by 400mm.	£245.00
(vi)	The Memorial Garden – Small stones size not to exceed 35cm by 40cm placed flat in the ground, at ground level.	£215.00
(vii)	(The fees indicated in Part 3 above include the first inscription) Each additional inscription thereafter.	£140.00

Note. All requests must be proposed with dimensioned diagrams in detail for Parish Clerk approval prior to any placement.
